GENERAL ORDER No. 18-1

Effective August 1, 2018, the Local Rules of Bankruptcy Procedure for the District of Arizona are amended as follows:

1. Local Rules 1000-1 through 2015-1 and 2090-1 to 9072-9 are superseded and replaced in their entirety and Local Rule 9076-1 is adopted. The Amendments supplement, or if permitted, modify the Federal Rules of Bankruptcy Procedure, and shall be construed to be consistent with such Rules to promote speedy and inexpensive litigation. The Amendments govern practice in all cases filed after July 31, 2018, and all pending cases unless the Court finds such application is not just and practicable.

2. The Court requires the use of certain Local Forms, which may be modified from time to time without prior notice. Changes to the procedures and/or forms will be posted on the Court's website. The Court adopts the following mandatory Local Forms:

- a. 1007-1, Declaration of Electronic Filing;

- b. 1007-2, Declaration of Evidence of Payments;
- c. 1007-3, Declaration Under Penalty of Perjury for Debtors Without An Attorney;
- d. 1017-1, Motion to Vacate Order of Dismissal and to Reinstate Case;
- e. 3003-1, Order Setting Claims Bar Date;
- f. 3003-2, Order Setting Initial Hearing on Approval of Disclosure Statement;
- g. 3003-3, Order Giving Notice of Approval of Disclosure Statement, Setting Initial Confirmation Hearing, and Fixing Deadlines;
- h. 7016(b), Notice of Scheduling Conference; and
- i. 7016-1, Joint Pretrial Statement.

3. The subject matter of General Orders 16-1, 107, 103, 101 and 99 having been addressed in the 2018 Rule Amendments, those General Orders are withdrawn.


4. All other General Orders currently effective shall remain in full force and effect.


