

# **Interactive Public Calendar**

The Interactive Public Calendar (IPC) powered by ChapMobile displays any scheduled court hearings withing the next 7 calendar days and 341 meetings within the next 30 calendar days. The IPC allows a user to:

- View current and upcoming hearings organized by judge and 341 meetings organized by trustee;
- Search by judge, trustee, attorney name, debtor, or case number; and
- Sort, view, download, and print custom calendars.

The IPC updates from CM/ECF approximately every 10 minutes. Instructions for navigating the calendar are below.

## **Using the Interactive Public Calendar**

The interactive public calendar will not display the Hearing Calendar and the 341 Calendar simultaneously. The Hearing Calendar is the home (default) screen.

To view the 341 Calendar, click the 341 Calendar link in the upper right corner.



Click the Hearing Calendar button to return to the Hearing Calendar.

#### **Hearing Calendar Navigation**

If a calendar date has hearings, you will see the dates in red, with a dot under the date. The calendar always defaults to the current date, and only shows hearings within the next 7 calendar days and none in the past. It will show 341 meetings in the next 30 calendar days.

On the date selected, you will see a list of Judges and locations for their hearings at the bottom of the screen:



The list of hearings is by judge and location. If a judge has "Telephonic", "Videoconference" or a specific Courtroom listed separately, that is because those are all considered different locations.

Each listing starts with a time, such as "9:00". That indicates when the first hearing of the day starts at that location. Select, for example, "10:00- Brenda K. Martin- Telephonic Hearing" and you will see all her telephonic hearings for the day.

Click on the judge/location choice and you will then see a list of *detailed hearings for the day* at that location.

When the Hearing Calendar displays, scroll down to view the list of pending matters. Click located in the right corner of the screen to download the calendar.

To view a calendar for a specific Judge, type the name of the Judge in the white search bar on the home screen.
