3 WHAT?

- The District of Arizona Bankruptcy Court is pleased to announce that commencing on <u>October 1, 2022</u>, new electronic payment methods processed through Pay.gov* will be available for Self-Represented Parties.
- There are 3 new methods of payments:
 - Automated Clearing House (ACH) Direct Debit payments
 - Debit Cards
 - PayPal Debit

*Pay.gov is operated by the U.S.Department of Treasury and is a web-based application that allows you to make online payments to government agencies by debit from your personal or business checking or savings accounts.

4 WHO?

- The Online Payment Program is for <u>self-represented parties</u> (commonly known as Pro Se).
- This payment program is <u>NOT</u> intended for use by registered ECF Filers (attorneys or limited filers) * The only exceptions are for copy requests or certified copy requests.
 - ECF Filers should continue to make payments of fees directly in ECF when filing a document with the Court.
- The following are **NOT** accepted through the Online Payment Program:
 - Chapter 13 plan payments to the trustee
 - Chapter II quarterly fees
 - Any and all fees that are not specifically identified as acceptable in this document
 - Payment for any fees that do <u>NOT</u> reach a total of more than \$5.00.All payments must be \$5.01 or more.

5 HOW?

- If you do not know the amount of the fee due or require additional information to make your payment, please contact the Financial Help Line at 602-682-4215.
 - Submissions for incorrect amounts may be returned unprocessed and have a negative impact to a case.
- Users must be able to describe the type of document and the total amount to be paid (e.g., case number, case name, installment payment).
- Click the **Online Payment Form** link to pay the following types of fees via electronic draft from your bank account (ACH), Debit Card, or PayPal Debit:
 - Petition filing fee installment payments
 - A request for a copy of court documents
 - A request for certified copy of document(s)

6 HOW?

- Once you select a payment type (ACH, Debit Card or Paypal Debit), enter the appropriate information requested on the screen.
 - ACH payment account number & routing number
 - Debit Card & PayPal card number, expiration date & possibly the 3-digit security number
