<u>BANKRUPTCY</u>. THERE IS NO ACTION REQUIRED ON YOUR PART UNLESS YOU CHOOSE TO TAKE IT. THIS NOTICE IS INFORMATIONAL.

#### WHY AM I RECEIVING A NOTICE IN THIS CASE?

You are receiving this notice because it is likely that Titan Solar Power (or one of its affiliated companies) installed solar panels at your residence or facility. Titan Solar Power has filed for Chapter 7 bankruptcy, meaning the company is no longer operational and will not be providing services to customers. As part of the bankruptcy process, the company is required to submit a list of all customers who may be affected by its closure. Individuals who may be owed money by a bankrupt company are considered "creditors." You may be one of the creditors in this bankruptcy.

### HOW AM I IMPACTED BY THE TITAN SOLAR BANKRUPTCY?

Each customer may have a distinct arrangement with Titan Solar Power. You can review your service agreements to determine the specific obligations Titan Solar Power was responsible for fulfilling. In some cases, Titan Solar Power provided installation and repair warranties for certain periods of time. Many customers are still making payments for their solar panels through a financing company. You may wish to contact your financing company to understand how the bankruptcy filing may affect your obligations or rights.

## WHAT IS THE NOTICE TELLING ME TO DO?

The notice you have received is a Notice of Claims Bar Date. This notice informs you that the Chapter 7 trustee is holding funds to distribute to creditors. The deadline to file a Proof of Claim form is March 11, 2025. The Proof of Claim form, which consists of three pages, allows you to detail the amount you believe Titan Solar Power owes you. While you have the option to file a Proof of Claim form, it is not a requirement.

### WHERE CAN I GET THE PROOF OF CLAIMS FORM?

The Proof of Claims form (Form 410) is on our court website. <a href="www.azb.uscourts.gov">www.azb.uscourts.gov</a>. There are two ways to file a Proof of Claim form. You can mail it into the Court or you can submit the information online, called an electronic proof of claim (ePOC). In order to be timely, the form must be RECEIVED by the Court on March 11, 2025, or an electronic proof of claim must be filed by that date.
