8 The Debtor has filed a motion to avoid lien of Wachovia Bank (Docket #16). The Debtor's
9 Motion was served at the domestic addresses of Wachovia Bank,, but not on the statutory agent. Nor is
10 the court persuaded that the party upon whom the motion was served actually received it, or was
11 authorized to receive service for the corporation.

12 FED. R.CIV. P. 4(h) provides that:

13 Unless otherwise provided by federal law, service upon a domestic or
14 foreign corporation or upon a partnership or other unincorporated
15 association that is subject to suit under a common name, and from which
a waiver of service has not been obtained and filed, shall be effected:

16 (1) in a judicial district of the United States in the manner prescribed for
17 individuals by subdivision (e)(1), or by delivering a copy of the summons
18 and of the complaint to an officer, a managing or general agent, or to any
other agent authorized by appointment or by law to receive service of
process and, if the agent is one authorized by statute to receive service and
the statute so requires, by also mailing a copy to the defendant

1 The court finds that the motion to avoid lien of Wachovia Bank was not served in accordance with
2 FED. R.CIV P.. 4(h)(1). Accordingly,

3 IT IS ORDERED that the motion to avoid lien of Wachovia Bank is DENIED without prejudice.
