This court has the authority to review fees paid to 17 Debtor's counsel pursuant to 11 U.S.C. § 329. After notice and hearing and review of the entire 18 case, this court now rules. 19 20 **PROCEDURE** 21 22 This case presents a "core" proceeding to the court. 28 U.S.C. § 157(b)(2)(A). 23 24 **FACTS** 25 26 The Debtor filed her Chapter 7 petition on August 13, 2012. The Debtor's schedules
