This matter has been come before the Court in conjunction with the Stipulated Judgment, Plaintiffs and Defendants, the "Parties", having agreed to place the Stipulated Findings of Fact and Conclusions of Law under seal of this Court, and good cause appearing:

THE COURT FINDS AS FOLLOWS:

- 1. The Parties have executed a Stipulated Judgment and Stipulated Findings of Fact and Conclusions of Law that have been filed with this Court.
- 2. Due to the sensitive nature of the Stipulated Findings of Fact and Conclusions of Law leading to the Judgment, the Parties agree that the Stipulated Findings of Fact and Conclusions of Law be held under seal of this Court pursuant to the terms of this Order.

THEREFORE IT IS HEREBY ORDERED AS FOLLOWS:

- 1. It is hereby covenanted by the Parties that the Stipulated Findings of Fact and Conclusions of Law entered in this matter shall remain under seal subject to the terms and conditions of a Forbearance Agreement entered into between the Plaintiffs and Defendants.
- 2.
