MEMORANDUM DECISION

13 The Chapter 7 Debtors have asked the court to avoid judicial liens which they contend14 have attached to certain personal property owned by them (ECF Nos. 19 and 20).

The Debtors filed for Chapter 7 relief on August 16, 2012. In their schedules, they
reflected ownership only of personal property (Schedule B), and <u>no</u> real property (Schedule A).
They now seek to "avoid" what they maintain are "judicial liens" against such personalty.

The affected creditors are:

- Capital One Bank, N.A.
- Sterling, Inc. (aka Sterling Jewelers)

23 (ECF Nos. 19, 20.)

However, judicial liens (as a result of a recorded judgment) only attach to <u>real property</u>.
ARIZ. REV. STAT. §§ 33-961; 33-964. Recorded judgments have no legal effect on personalty
owned by a debtor.

1	Thus, neither of the recorded judgments has created judicial liens against the Debtors'
2	personal property. And, since the Debtors own no real property, the "avoiding" of those
3	judicial liens is unnecessary.
4	Thus, unless the Debtors have legal authority that a lien has been created, by operation
5	of Arizona law, upon their personal property (this court is not aware of any such statute), it
6	would appear that the motions are moot. This court cannot grant the relief sought, because no
7	wrong has been done to the Debtors which needs to be undone.
8	Accordingly, an order will be entered which denies each motion, as moot.
